WHY CAN'T ALL UNIT OWNERS VOTE ELECTRONICALLY?

UNTIL THE BYLAWS FOR THE MASTER ARE AMENDED, ONLY THE 114 ASSOCIATIONS ARE THE MEMBERS AND THEREFORE ONLY THE PRESIDENT OR HIS/HER DESIGNEE CAN VOTE.

CAN THIS SERVICE BE USED TO SURVEY RESIDENTS FOR INPUT AND FEEDBACK?

ABSOLUTELY! ALL 5,595 UNIT OWNERS WILL BE ABLE TO PARTICIPATE IN SURVEYS.

FLORIDA STATUTE SECTION 720.317 (WHICH ENCOMPASSES 718) OF THE HOMEOWNERS ASSOCIATION ACT

Question: WHO TALLIES THE VOTES AND SURVEY RESULTS?

Answer: BECKER BALLOTS

HOW LONG HAS BECKER BALLOTS BEEN IN BUSINESS?

Answer:

SINCE 2016 WHEN THE LAW PERMITTING VOTING WAS PASSED. THEY WERE THE FIRST FLORIDA-CENTRIC ONLINE VOTING OPTION FOR COMMUNITY ASSOCIATIONS.

Question: HOW DO YOU PREVENT VOTER FRAUD

Answer:

INDUSTRY STANDARD INCRIPTION (SSL) FOR OUR SITE AND DOCUMENTS; DATA IS SECURED AND DATA IS NEVER SHARED. EACH MEMBER IS ASSIGNED A UNIQUE ACCOUNT AND THEY CREATE THEIR OWN PASSWORD. ALL PASSWORDS ARE INCRIPTED WITHIN THE APPLICATION. NO RECORDS OF PASSWORDS ARE KEPT. THIS APPLIES TO VOTING AND POLLING.

HOW LONG DOES IT TAKE TO GET THE RESULTS OF A VOTE OR SURVEY?

THE WINDOW TO VOTE/POLL IS 21 DAYS; WHICH WOULD ALLOW FOR ANY PAPER BALLOTS AS WELL. PAPER BALLOTS ARE AVAILABLE FOR VOTING ONLY. SURVEYS WILL BE ONLINE ONLY.

YOU CAN STILL VOTE VIA PAPER BALLOT IF YOU CHOOSE TO OPT OUT OF ELECTRONIC VOTING. HOWEVER, SURVEYS WILL BE ONLINE ONLY.

THE NEW PRESIDENT IS GIVEN THE OPTION TO VOTE AND THE PREVIOUS VOTE IS VOIDED

WITH APPROPRIATE BYLAW CHANGES, ELECTRONIC VOTING MAY BE ABLE TO BE USED FOR A VARIETY PURPOSES TO OBTAIN THE OPINIONS OF OUR UNIT OWNERS.

Question: WHY ARE WE DOING THIS?

NO NEED FOR PROXY VOTES; VOTE REMAINS OPEN UNTIL A QUORUM IS REACHED; SNOW BIRDS CAN VOTE; MULTIPLE QUESTIONS PER VOTING EVENT; MONEY SAVED ON POSTAGE; THE ABILITY TO GET INPUT FROM ALL RESIDENTS.
